Shipping Fee: The amount charged to collect the stallion and ship the semen. Varies, depending where the semen is shipped to. In the US, the amount is approximately \$250.00. The \$250.00 is payable directly to the facility that collects the stallion. This is separate from the stud fee and barn handling fee.

Triple M Stables, LLC, A Walking Horse Ranch, Marsha Miller, personally, and any other person, will not be responsible for lost, damaged, or delayed semen. This contract has a live foal guarantee. This is defined as a foal that stands and nurses. Breeder must be notified within 7 days, and sent veterinarian certificate, if the foal does not stand, nurse, or the mare slips the foal. Rebreeding is guaranteed for the contract mare or another mare as agreed to by both the mare owner and the breeder. Rebreeding applies to the STUD FEE ONLY. All other fees are the responsibility of the mare owner. Should the stallion die or become unfit for breeding as determined by a licensed veterinarian, this contract becomes null and void. Absolutely no refund of booking fee or stud fee.

The breeding season will be from March 1st to November 31st. The stallion will not be collected July 15th through September of the breeding season. There may be some exceptions to this, depending on where the mare resides.

Mare owner acknowledges that the breeder STRONGLY recommends pregnancy checks via ultra-sound at 17 days and by palpation at 45 to 60 days. Breeder STRONGLY recommends Rhino vaccinations at 5-7-9 months, plus the normal vaccinations appropriate for the mare owner's locale.

Insurance on the mare is STRONGLY recommended.

The breeder will not be responsible for any mare not conceiving or aborting during pregnancy.

This contract may be assignable and transferable upon approval from Triple M Stables, LLC.

Registrations papers for the foal will not be signed by stallion owner until the stud fee is paid in full and any expenses owed, are paid in full.
